### Integrity Commissioner

Council approved the reappointment of Tony Fleming as Integrity Commissioner. Tony Fleming, of Cunningham Swan Carty Little & Bonham LLP, has served as the South Dundas Integrity Commissioner since March 5, 2019. The Municipal Act, 2001, requires every municipality in Ontario to have a formally appointed Integrity Commissioner. The role of the Integrity Commissioner is to provide ethics-related education to elected officials as requested, as well as determine compliance with Council's Code of Conduct or other ethics-related policies or procedures.

"We need to have an Integrity Commissioner...Mr. Fleming, his office is excellent...I certainly appreciate all of the work they do for us", noted Mayor Broad.

### April 8<sup>th</sup> Total Solar Eclipse

On April 8, 2024, at approximately 3:24 p.m. South Dundas and the surrounding region (SDG Counties) will experience a once-in-a-lifetime event, a total solar eclipse. A narrow band, known as the 'path of totality' will transit across our region, as the Moon completely blocks the sun and turns day into night for a little more than two minutes. Municipalities in Ontario that are within this narrow band of totality are bracing for a mass migration of eclipse enthusiasts that are expected to travel to view the spectacle.

"Tens of thousands of people could visit our region and we wanted to get plans in place for emergency response", mentioned Mayor Broad.

Staff anticipate the potential for significant traffic impediments on key thoroughfares, including CR2, CR31, CR43, and Highway 401. Staff have engaged SLPC representatives, who indicate that there is on-site parking for only a few hundred vehicles. A nearby landing strip, located across CR2, is expected to open to allow for additional parking. Likewise, the Upper Canada Golf Course could be used for parking spillover as well. South Dundas welcomes visitors to our region, and we encourage residents to enjoy the spectacle safely and responsibly. To that end, residents will be urged to stay home, if they can, to enjoy the eclipse from the sanctity of their backyard or balcony. This is being done to mitigate traffic congestion as much as possible. SDG Counties and South Dundas will prepare a communications campaign that will include

regular social media posts, traditional media engagement and web updates. Communications will begin the first week of March and last until eclipse day.

Approved eclipse glasses will be provided to all staff working out in the field. South Dundas Fire and Emergency Services will staff a minimum of 5 personnel (10:00 a.m. - 6:00 p.m.) at each station to ensure emergency responses. Should there be a need for fire staff to stay later, SDFES will be prepared to keep staff longer. Staff have been identified in Parks, Recreation, Facilities, Roads, Water/wastewater, and some administrative staff to work outside of their regular scheduled hours to ensure availability to the public if an emergency does occur. All Municipal vehicles will be fueled in advance of April 8th and strategically parked so they can respond to calls, if needed. Additionally, the Fire Chief in collaboration with Brockville dispatch will be completing testing on the backup systems for 911 dispatch in the event of a communication network failure.

"With the potential of emergencies during a gridlock, we need to be ready", stated Deputy Mayor St. Pierre.


"I think is it great we are moving forward with cycling", noted Councillor Ward.
