

**THE CORPORATION OF THE MUNICIPALITY OF SOUTH DUNDAS**

**BY-LAW NO. 2014-64**

**A BY-LAW to amend By-Law No. 2002-15 to provide for licensing of dogs and to prohibit dogs running at large.**

**WHEREAS** the Municipality of South Dundas has established licensing of dogs and has regulated dogs running at large;

**AND WHEREAS** it is deemed necessary to amend the Canine Control By-law to regulate unattended dogs running at large;

**AND WHEREAS** the *Municipal Act, 2001*, as amended, provides authority to municipalities to establish fines for offences;

**NOW THEREFORE** the Council of the Corporation of the Municipality of South Dundas enacts as follows:

1. That Section 10 (a) be amended by adding the following:
  - iii) No owner or person with care or control of any dog shall allow the dog to be at large or unattended in the Municipality of South Dundas.
2. That Section 19 be removed and replaced by adding the following:
  19. Every person who contravenes or causes or permits any contravention of any of the provisions of this By-law is guilty of an offence and on conviction is liable to a fine as provided for in the *Provincial Offences Act*, R.S.O. 1990, Chapter P.33, as amended.
3. That Schedule "A" to By-Law No. 2002-15 be deleted in its entirety.
4. That the fines shall be set as per Schedule "A" attached to this By-law.
5. That all other terms and conditions of By-Law No. 2002-15 remain unchanged.
6. This By-law shall come into full force and effect on the date of passing.
